### **Online Banking Disclosure**

S&T Bank hereby publishes the following terms and conditions for use of S&T's Online Banking service. S&T Bank reserves the right to modify these terms and conditions at any time, effective upon publication. The User's use of the services constitutes agreement to these terms and conditions and any modifications thereof.

- I. User agrees that the following uses of the services are strictly prohibited. User agrees to indemnify, hold harmless, and defend S&T Bank from and against any and all claims, actions, suits, judgments and expenses (including court costs and reasonable fees of attorneys, accountants and expert witnesses) at User's sole expense, arising from User's failure to abide by these restrictions on use of the services.
  - A. Unauthorized communication of any change or credit card information belonging to any other person or entity;
  - B. Unauthorized communication of any information concerning any password or other online access number, code, or identification or any other proprietary information belonging to any other person or entity;
  - C. Use of the services to copy or to distribute or transmit copies of copyrighted materials belonging to any other person or entity is permitted only to the extent that the owner has provided express permission to the User permitting such activity. Copying or distribution or transmitting copyrighted materials other than with permission as specified above is expressly prohibited;

3. User further agrees:
  - A. Transmission of confidential business and sensitive personal information is at Customer's sole risk.
  - B. S&T Bank reserves the right to monitor and review transmissions online and in storage, and to remove or reject any material which S&T Bank, at its sole discretion, believes may be unlawful or objectionable, without prior notice to User.
  - C. The User Identification Code and Passwords issued to the User is for security purposes. The numbers and/or letters are confidential and should not be disclosed to third parties. User understands that the User Identification Code and Passwords identifies User and authenticates and validates directions given as would User's actual signature. User therefore agrees to take reasonable precautions to protect the integrity of user identification code and password including but not limited to the following:
    - i. Not to disclose User's identification code or password to any other individual.
    - ii. Not to write User's identification code or password on any literature which may be easily accessed by another individual.
    - iii. To indemnify and hold harmless S&T Bank for any unauthorized transactions resulting from User's disclosure of User's identification code or password to any other individual.
4. Our business days are Monday through Friday. Federal holidays are not included.

#### **Funds Transfer & Bill Pay**

- A. Federal Regulations limit preauthorized, automatic, telephone and other transfers from savings and money market accounts to a total of six (6) per statement cycle per account.
- B. The Bank shall have no duty to verify the identity of the person using a valid access code to transfer funds.
- C. The account owner(s) agree(s) to indemnify and hold the Bank harmless against any claims, demand, costs or expenses resulting from or arising out of any unlawful or unauthorized requests for funds transfer or in failing or refusing to make any requested transfers.
- D. Transfer requests, will be accepted at any time provided all systems are operational. The transfer will be posted on a business day during regular processing hours. Transfers made after 8.00 p.m. EST may not be posted until the next business day.
- E. The Bank may discontinue this service at time.
- F. The account owners) agree(s) to pay any applicable service charges for transfers shown in Bank's Fee Schedules.
- G. The account owner(s) agree(s) to notify the Bank immediately if they become aware that an unauthorized individual has knowledge of the access code.
- H. Bill Payment and Funds Transfer services may not be available on those accounts requiring two signatures.
- I. User agrees to maintain sufficient funds in the bill pay funding account on the transaction payment date requested. Expedited payments will be debited from the funding account immediately.

#### **Limitation of Liability**

In no event will S&T Bank be liable for indirect, special, incidental or consequential damages arising out of the use of online banking services including, without limitation, damages or costs relating to the loss of profits, business, goodwill, data or computer programs, even if advised of the possibility of such damages.

## Termination or Discontinuation

In the event you wish to discontinue the service, you must contact us in writing. Written notice of service discontinuance must be supplied 10 business days prior to the actual discontinuance date and must be sent to:

Neither termination nor discontinuation shall affect your liability or obligation under this agreement. The service reserves the right to refuse to pay a Payee if your Designated Account has insufficient funds, a payee refuses to accept a payment, you attempt to make tax or court related payments or other good cause.
4. Since service cancellation requests take up to 10 days to process, you should cancel all outstanding payment or transfer orders in addition to notifying us of your desire to terminate the service. We will not be liable for payments or transfers made due to the lack of proper notification by you of service termination or discontinuance for any reason.
